- 1) In accordance with Section 98 of Act No 134/2016 Sb., on Public Procurement, as amended (hereinafter the “Act”), the Contracting Authority provides the following explanation of the procurement conditions:

Inquiry:

“Please provide reference models of the required instruments in order to determine the exact and specific types, so as to avoid a situation where the quality and nature of the instrument comply with the specifications but fail to meet the qualitative requirements in terms of artistic and technical standards.

JAMU students rank among the best in the field of music education, and in order to study and perform within the school and to remain competitive on a global scale, it is essential that they use instruments that are standard for professional musicians and belong to the world’s top instruments used by leading soloists as well as members of the leading and most prestigious orchestral ensembles. We therefore request the reference models on which the Contracting Authority has based the required quality, so that we can at least match it.”

Response from the Contracting Authority:

The Contracting Authority has amended Annex No 1 - Technical Specification of Equipment and Price Calculation by including the reference instruments.

- 2) In accordance with Section 99 of the Act, the Contracting Authority announces the following amendment to the procurement conditions:

The Contracting Authority amends the fulfilment period specified in Article V(1) of the Procurement Documentation as follows:

“The supplier is obliged to fulfil the subject of the public contract

- **for Part 1 - Combined Percussion Instruments no later than 10 October 2025,**
- **for Parts 2-9 no later than 30 November 2025**

The supplier is also entitled to fulfil it on any working day following the publication of the contract in the Register of Contracts of the Czech Republic, between 9:00 a.m. and 3:00 p.m.”
